The Mend & Make Do Crew Inc. Local Produce Market is a community initiated and operated market held every Saturday morning from 07:00 to noon at the Crew's Headquarters located at 46 Through Street, South Grafton, New South Wales.

### **MARKET ETHOS**

The Mend & Make Do Crew Inc. Local Produce Market provides a positive, inclusive and empowering environment for both Stall Holders and Customers.

Through facilitating a regular venue for producers to market their produce to our local population and tourists to the region, The Mend & Make Do Crew Inc aims to build the commercial confidence and skill of the producers.

The Mend & Make Do Crew Inc has two articles of association:

1. Social Inclusion through recycling based Arts & Crafts
2. Using our members Arts & Crafts Skills to support other not for profits

The Mend & Make Do Crew Inc. Local Produce Market is an entirely volunteer run market with all stall fees being donated directly to The Mend & Make Do Crew Inc Homelessness Project.

THE MEND & MAKE DO CREW INC. LOCAL PRODUCE MARKET empowers local producers by:

1. A regular, clean, large and accessible venue for producers and buyers
2. A welcoming & inclusive environment for all market participants
3. An event that promotes the Heritage Listed South Grafton CBD

## GLOSSARY OF TERMS

### LOCAL

The Mend & Make Do Crew Inc. defines **local** as any producer based in the Clarence Valley, NSW or nearby surrounding areas.

### ELIGIBILITY

To be **eligible** to be a Stall Holder at our Market your products must be locally grown or produced.

### PRODUCTS

**Products** can be fresh produce, food, art, crafts and music!

### COMPLIANCE

All products must **comply** with any relevant government legislation or regulations.

All fresh produce and food must **comply** with associated regulations and where necessary Stall Holders will need to obtain the relevant Clarence Valley Council approvals before participating in our markets.

### MARKET ADVOCATE

A volunteer of The Mend & Make Do Crew Inc with the honour of being the contact person for our Markets.

## STALL HOLDER APPLICATION PROCESS & FEES:

### APPLICATION

Interested local producers wanting to be part of THE MEND & MAKE DO CREW INC. LOCAL PRODUCE MARKET are invited to complete the Stall Holder Application Form (see pages 3 and 4 of this document). Once completed the application form can be submitted via email or hard copy.

### FEES

- Marquee 3 X 3 metres \$10
- Marquee 3 X 3 metres with electricity \$15

### STALL APPLICATION PRIORITY

If the number of applications for THE MEND & MAKE DO CREW INC. LOCAL PRODUCE MARKET exceeds the available stalls, or there are too many applications to sell the same type of produce, the Market Advocate will prioritise applications based on providing variety for the Markets customers and the basis for these decisions will be provided to applicants in writing.
